## Release Agreement

### PLEASE READ THIS SCoNE RELEASE CAREFULLY BEFORE SIGNING

In consideration of being permitted to join Sprint Cars of New England (hereinafter called "SCoNE") and being permitted to participate in or be a spectator at SCoNE membership events during 2017 I hereby:

1. Release, waive, discharge, and promise not to sue SCoNE, any of it's officials, any of it's members, any of it's sponsors, or car owners, drivers, pit crews, for personal injury or property damage which I sustain during 2018 arising out of an SCoNE event, whether my loss is caused by the negligence of SCoNE or its members. This does not waive rights of suit in the event that an action is termed criminal within the jurisdiction of applicable law.
2. Agree to indemnify and hold harmless SCoNE, its officials and members for any loss, liability, damage, or cost which may incur due to my presence at a SCoNE event, whether I am competing, officiating, or observing a SCoNE event.
3. Assume the risks inherent in automobile racing and assume responsibility for the bodily injury or property damage which those risks can cause.
4. Reserve to SCoNE and its members and officials, any rights to publish, produce, copyright, duplicate, reproduce upon hats, tee-shirts, and other such novelty concession items, written articles about me, photos and drawings of my likeness or of my race car. This does not prohibit me from producing promotional products, nor does this allow SCoNE to take any proceeds from material produced by me, unless marketed by SCoNE.
5. By signing below, agree to follow all the rules and regulations and responsibilities as printed in the 2018 SCoNE rules. I hereby release the officials of SCoNE from damages resulting from their decisions and/or interpretations of rules.
6. Have read the forgoing and understand its contents and agree that if any of the paragraphs or provisions of this contract are deemed illegal, the rest of the document shall stand in full force and effect.
